*Dear Miss Godoy Alcayaga:
We admire your initiative
I ask your cooperation*

You are one of a few leaders in each country
who are invited to collaborate in improving
the enclosed draft for a Declaration of
Interdependence.

It differs from the American Declaration
(1776), the French Universal Declaration of
Human Rights (1789), the United Nations
Charter, etc., in that it is an agreement
among individuals, not among governments.
It is not being presented to any legislative
body, national or international, for adoption.

Collaborators are invited to correspond with
one another (list available late 1952). Col-
laborators on this preliminary draft include
18 educators, 16 authors and editors, 15 re-
ligious leaders, 10 business men, 7 business
and professional women, 5 architects and
artists.

This is a long-term project to establish continuing relationships across
frontiers among men of good will living under all conditions of economic de-
velopment. The original signers (limited to about 300) are:

invited to write or circulate educational material about the Declaration
in the language of their own country;

requested not to attach the Declaration to any political party or personage;

The organization of the Interdependence Council is informal. Each signer in
each country has complete freedom of action within the framework of the
Declaration. No resolutions will be proposed and no money solicited for the
international office.

Will you please make suggestions for the improvement of the Declaration of
Interdependence or associate yourself with its general objectives by signing?
