My dear Mme. Mistral:

I am confident that you are familiar with Rosika Schwimmer's life-long work for world peace and human freedom. Many of us have been anxious for a long time that her work receive recognition through the award of the Nobel Peace Prize. Already on two occasions the award has been made to her co-workers in peace activities which were initiated and organized by Rosika Schwimmer.

I hope you will agree that this ignoring of her efforts to create a warless world must be corrected. On September 11, 1947, Rosika Schwimmer will be seventy years old. Another life as rich and crowded with epic struggles for human freedom and world peace would be difficult to find.

The enclosed biographical material describes a few of her activities. Any one of them would be enough to distinguish her. The sum total of her achievements is breath-taking in its scope and creativeness.

I hope you will join in this effort to produce the tangible evidence of our appreciation and gratitude by securing for her the Nobel Peace Prize.

You are entitled to propose candidates. I trust you will nominate her for the 1948 Peace Prize in recognition of her lifelong work for the preservation of human liberty, mediation of international conflicts and the creation of a world order providing peace and justice for all under law. Rosika Schwimmer's magnetic personality, like that of Baroness Bertha von Suttner, stimulated world-wide peace activity. Please address your nomination, and reasons for it to:
