Dear Jack:

This is to settle up my account with The Johns Hopkins University Press for the 50 paperbacks and 5 cloth copies of my book which I took from your office while visiting there last summer.

With various lectures here and there - Lenox Arts Center, Lenox, Mass.; Columbia University, New York City; Cabrini College, Radnor, Pennsylvania; and The Bryant Library, Roslyn, New York - I have now been able to sell all of them. Eight were given away for Promotion, and two paperbacks were picked up without being paid for at one of the lectures. Also THE BOOK STORE in Lenox, Mass. bought three copies from me and withheld their regular 40% discount. (Their check is enclosed.)

To make our figures simpler and because it comes out roughly the same, I am simply turning over full payment to you minus 25% discount which you allow any bookstore. (See attached statement.) This leaves me without a loss, though certainly with no profit.

Since I have been acting as your "roving bookstore," this discount in no way alters the normal royalties I am entitled to for these sales.

I hope everything is going well in Baltimore. Nargot Schutt and Frank Saul are coming with me and a group of friends on December 11th to see "The Last of Mrm. Lincoln," starring Julie Harris, the play in which my sister plays the part of Mrm. Lincoln's sister. I've already seen it in Washington and it is splendid!

Frank arranged a lecture for me at Cabrini College. He did a marvelous promotional job and it means more lectures next Spring for me, including my Alma Mater, Bryn Mawr. Cabrini College was delighted with his work and with the success of the evening.

I'm off to the Caribbean for a time. My address will be c/o James Needham, "The Flamboyant", Box 214, St. George's, GRENADA, West Indies. I know that mails are very slow there. If there should be anything urgent, you might get in touch with Joan Daves.
