Dear Miss Daves:

I answer your letter of June 14, 1963. You mention there another letter dated April 17th. Unfortunately I never received this one. I have been out of the country for more than four weeks which explains my delay in answering your last letter. I hope there is still time to finish our arrangements before Miss Dana's tour in Central America.

I want to reassure Miss Dana on our interest of making this recording another chapter of a first-quality collection.

On this point we have the opinion of well-known experts on the past fourteen records and the cooperation and Advisory of highly skilled international technicians.

The cooperation of Miss Dana in doing the editing of the Library of Congress material is more than welcome, and we shall gladly accept her selections on a time of recording covering twenty minutes for each side of the record. That is a total of forty minutes.

As of your supplemental questions I shall answer in the same order.

1)- We are thinking in distribution in central America and the royalty terms would be the same outlined in my letter for all countries. We have excellent distribution facilities in Mexico and Spain.

2)- Yes, 9% of the list price is the mathematical equivalent of the commercial formula used here for stating the royalty terms (10% off 90% of the list price).
