Dear Doris:

Your letter of June 7 just received. Financially we are even (hope you are satisfied). Very glad to hear how smoothly the problems are going.

Right now I'm getting estimates on the moving--at the beginning I was really flying but, thank goodness, I pulled the trucks and they worked!

SHAKESPEARE LIBRARY: no hurry, he's doing nothing now and asked me about it. I thought if you wanted the typewriter he could take it along.
TYPEWRITER--I really haven't decided yet to sell it, this machine has changed my IBM plans, at least for the present. did you receive a letter from IBM for me? Gave them Spruce Street thinking they would answer immediately. The typewriter (L.C. Smith, Silent, 1938 model) I paid \$100 (\$80 and \$20 for type changes--can write Spanish, French, German, Portuguese etc.) I would sell (if I decide) for \$60.
