Dear Miss Dana:

RE: Estate of Gabriela Mistral.-

I acknowledge receipt of yours of August 18th and enclosed Power of Attorney. With this and the documents that you sent before, we will proceed to take the steps ordered by our Law in connection with the estate of Gabriela Mistral.

According to the information gathered by us, there are no other properties than those we mentioned in our letter of May 7th and unless otherwise instructed by you, we will proceed on that basis.

Empresa Editora Zig-Zag has informed us in answer to our request, that they have a balance covering royalties up to January 10th, 1957, in the amount of Ch.\$ 585.050.- We will proceed to collect this money unless you give us other instructions.

Mr. Jaime Varela who was in charge of Gabriela Mistral's interests in La Serena, informed us that the property in that city was leased in the sum of Ch.\$ 12,000.- The proceeds of the lease for 1957 were collected by him and sent to Mr. Rufomiro Tomas. We will write again to Mr. Varela to enquire what has become of the rent for 1958.

I would like to receive instructions in connection with Editorial El Pacifico. The status of this matter is already in your possession.

I have no information in regard to the intentions of the Government to remove the remains of Gabriela to Monte Grande. I will enquire about this matter, but I don't think anyone is paying much attention to this removal for the moment, as the interest of the people of this country is centered in the next presidential election which will take place in a couple of weeks.
