
We will also contact Empresa Editora Zig Zag S.A. and Editorial del Pacifico S.A., so as to pay to the same Order all the royalties due after her death.

We have received a letter from C. Della Penna S.A. from Buenos Aires, asking for the authorization to publish four of Gabriela's poems printed on the covers of exercise books for children. They have been doing this with other poets, as shown in the enclosed leaflet. They are not doing business selling the poems themselves and, therefore, ask for permission to print them without payment, because it is a divulgation of Gabriela's work for the children and printed, as aforementioned, on the cover of the books. Will you kindly tell us if we can authorize these publications?
